Minutes of the Air, Land, NC Detachment 1257 Monthly Meeting: 8Jan2019

#### F. PAYMASTER'S REPORT

Paymaster provided a financial report to the Board of Trustees and reported that the Detachment's finance's are in good condition. The details will no longer be posted to the minutes, since these minutes are now public information on the website. One item of note; SVC Glenn made a \$200 donation to the Detachment. #### REPORT OF OFFICERS

- 1. P/M Whalen noted that our next gun shows are at the State Fairgrounds on 19-20Jan2019 and 26-27Jan2019 at the Greensboro Coliseum. Ed asked for volunteers and enough members volunteered to fill the time slots.
- 2. Commandant Brown and P/M Whalen noted the gun shows are not as well attended as in the past and customers are shopping prices against internet sellers. Few attendees spend money at the shows and find lower pricing on the internet or at local gun stores. We need to find alternate places to sell raffle tickets or other ways to raise money. This might include internet sales, credit card sales, an annual public dinner, an additional raffle, etc. Members should give thought to fund raising and pass these ideas on to the Board of Trustees.
- 3. SVC Glenn presented an idea for raising funds through the new natural gas supplier in North Carolina, Dominion Energy. Dominion has a \$1,000,000 grant program for 501©3's that can award up to \$15,000. If we have someone in the Detachment who knows how to write grants, we can apply, based on the charitable giving that we do.
- 4. SVC Glenn talked about the Wake Forest Community Calendar on the town website. Many of the organizations in Wake Forest note their meetings and events on the calendar and Jerry thought the Detachment should do so also. Doug Doster includes us on the American Legion online calendar, but this is typically only seen by members of AL, VFW and MCL. Adjutant Kemeny will contact Bill Crabtree at Town Hall and input information for the town calendar.
- 5. Commandant Brown visited the MCL Ship's Store to obtain staff ribbons for our members. He also attempted to obtain the medal for our current Marine of the Year. This medal is in the mail. He will finish compiling the list and provide the ribbons to appropriate members so that they can wear them.
- 6. Commandant Brown noted that Bingo at the VA Hospital will be on 6Feb2019; all are invited. The next Wake Forest flag raising will be on

1Apr2019 for a female Navy vet. The 6May2019 flag raising will be for our Detachment member, George Cattalona.

#### H. OLD BUSINESS

1. Commandant Brown discussed the new detachment website, airlandnc.org. The website is up and running, but includes little information to date. Keep checking on it and Web Sgt. Doster will have it operational and useful in the near future. As part of the new website, Web Sgt. Also, as part of the website, Commandant Brown has set up a Magic Jack telephone answering service at (919)745-1257. All of this should be operational in the near future.

Terry was honored for his support of Detachment fund raising, services on the Detachment Board of Trustees, volunteer efforts and donations to the USO, constant trips to Camp Lejeune and Fort Bragg delivering service members from the airport to their duty stations, and other efforts in the local community.


**Commandant Brown** closed the meeting at approximately 2000 hours and the closing ceremony was held.
